

17-16-6.5. Campaign financial disclosure for any candidate for office, including the candidate for office, shall be made available to the public in accordance with the provisions of this section.

(a) The candidate for office shall file with the county clerk a financial campaign report which shall include the following information:

- (1) A statement of the total amount of contributions received by the candidate for office during the reporting period, including the name and address of each contributor, the amount of the contribution, and the date the contribution was received.
- (2) A statement of the total amount of campaign expenses incurred by the candidate for office during the reporting period, including the name and address of each payee, the amount of the expense, and the date the expense was incurred.
- (3) A statement of the total amount of contributions received by the candidate for office during the reporting period, including the name and address of each contributor, the amount of the contribution, and the date the contribution was received.
- (4) A statement of the total amount of campaign expenses incurred by the candidate for office during the reporting period, including the name and address of each payee, the amount of the expense, and the date the expense was incurred.

(b) The candidate for office shall file with the county clerk a financial campaign report which shall include the following information:

- (1) A statement of the total amount of contributions received by the candidate for office during the reporting period, including the name and address of each contributor, the amount of the contribution, and the date the contribution was received.
- (2) A statement of the total amount of campaign expenses incurred by the candidate for office during the reporting period, including the name and address of each payee, the amount of the expense, and the date the expense was incurred.
