## MUNICIPAL CAMPAIGN FINANCE STATEMENT TO: KIM E HOLINDRAKE, CITY RECORDER, CITY OF CEDAR HILLS

- A. **Purpose and intent.** The purpose of this document is to comply with Section 10-3-208 of the Utah Code Annotated for candidates for elective office in the City of Cedar Hills, Utah.
- B. Definitions.
  - Contribution means a gift, subscription, donation, loan, advance, or deposit of money or anything of value received before the close of the reporting date.
  - Expenditure means any disbursement, purchase, payment, donation, distribution, loan, advance, deposit, gift of money, or anything of value made for political purposes before the close of the reporting date.
  - \$ Reporting limit means \$50.
  - \$ Municipal Primary Election means the election held in municipalities on the second Tuesday following the first Monday in the September before the Municipal General Election.
  - \$ Municipal General Election means the election held in municipalities on the Tuesday after the first Monday in November of each odd-numbered year.
- C. **Filing**. Each candidate for municipal office shall file with the City Recorder a campaign finance statement.
  - Candidates who are eliminated at the Municipal Primary Election shall file with the City Recorder a campaign finance statement no later than 30 days after the Municipal Primary Election. (Thursday, October 13, 2011)
  - 2. Candidates who are NOT eliminated at the Municipal Primary Election shall file with the City Recorder a campaign finance statement no later than seven days before the Municipal General Election (Tuesday, November 1, 2011) and again no later than 30 days after the Municipal General Election (Thursday, December 8, 2011).
- D. **Reporting.** The campaign finance statement must include the following information through the close of each reporting date.
  - The total amount of all campaign contributions and expenditures if the candidate receives \$500 or less in campaign contributions and spends \$500 or less on the candidate's campaign.
  - 2. For each contribution that exceeds the reporting limit (\$50.00), the amount of the contribution and the name of the donor; and the aggregate total of all contributions that individually do not exceed the reporting limit (\$50.00).
  - 3. For each campaign expenditure, the amount of the expenditure and the name of the recipient of the expenditure.
- E. Classification. The signed campaign finance statement received by the City Recorder is classified as a public record.
- F. Failure to File. Removal of the candidate's name from the ballot or blacking out the candidate's name before the ballots are delivered to the voters and/or notify voters that the candidate has been disqualified and votes will not be counted.
