In the event a candidate has no contributions or expenditures during a reporting period, a financial statement which states there were no contributions received or expenditures made must still be filed.

A person is considered a candidate and must begin filing financial disclosure reports if one or more of the following occurs:

- · The individual files a declaration of candidacy for municipal office; or
- The individual receives contributions, makes expenditures, or gives consent for any other person to receive contributions or make expenditures to bring about the person's nomination or election to a municipal office.

Every candidate is required to have a separate campaign account in a financial institution; and may not deposit or mingle any campaign contributions received into a personal or business account.

Utah Code Annotated § 10-3-208

Penalties for Failure to File Timely Disclosure

If a candidate fails to timely file a campaign finance statement required, the municipal clerk or recorder shall: notify every opposing candidate for the municipal office that the candidate is disqualified; send an email notification to each voter who is eligible to vote in the municipal election office race for whom the election official has an email address informing the voter that the candidate is disqualified and that votes cast for the candidate will not be counted; post notice of the disqualification on a public website; and if practicable, remove the candidate's name from the ballot by blacking out the candidate's name before the ballots are delivered to voters; and may not count any votes for that candidate. An election official may fulfill the requirements described in Subsection (11)(c)(i) in relation to a mailed ballot, including a military overseas ballot, by including with the ballot a written notice: informing the voter that the candidate is disqualified; or directing the voter to a public website to inform the voter whether a candidate on the ballot is disqualified. Utah Code Annotated § 10-3-208.
