

In the event a candidate has no contributions or expenditures during a reporting period, a financial statement which states there were no contributions received or expenditures made must still be filed.

A person is considered a candidate and must begin filing financial disclosure reports if one or more of the following occurs:

- The individual files a declaration of candidacy for municipal office; or
- The individual receives contributions, makes expenditures, or gives consent for any other person to
 receive contributions or make expenditures to bring about the person's nomination or election to a
 municipal office.

Every candidate is required to have a separate campaign account in a financial institution; and may not deposit or mingle any campaign contributions received into a personal or business account.

Utah Code Annotated § 10-3-208

Penalties for Failure to File Timely Disclosure

If a candidate fails to timely file a campaign finance statement required, the municipal clerk or recorder shall inform the appropriate election official who shall: if practicable, remove the candidate's name from the ballot by blacking out the candidate's name before the ballots are delivered to voters; or if removing the candidate's name from the ballot is not practicable, inform the voters by any practicable method that the candidate has been disqualified and that votes cast for the candidate will not be counted; and may not count any votes for that candidate. Utah Code Annotated § 10-3-208.
