



1. A gift, subscription, donation, unpaid or partially unpaid loan, advance, or deposit of money or anything of value; or
2. A contract, promise or agreement express or implied whether or not legally enforceable to make a contribution; or
3. A transfer of funds from a political committee, a party committee, another candidate, an officeholder, or a personal campaign committee to a candidate or a candidate's personal campaign committee; or
4. A payment for the personal services of another person by a person other than the candidate's personal campaign committee for services rendered to the candidate or such candidate's personal campaign committee; or
5. Goods or services provided at less than fair market value to or for the benefit of a candidate or a candidate's personal campaign committee.

"Contribution" shall *not* include:

1. Personal services provided without compensation by individuals volunteering their time on behalf of a candidate or such candidate's personal campaign committee; or
2. A loan of money by a national or state bank made in accordance with the applicable banking laws and regulations and in the ordinary course of business .
