**PLEASE TAKE NOTE OF THE CITY'S REQUIREMENT REGARDING POLITICAL ACTION

Utah Code Annotated 10-3-208, it its entirety; and West Jordan Municipal Code, 1-7A-7 UCA 10-3-208:

"(5) Notwithstanding any provision of Title 63, Chapter 2, Government Records Access and Management Act, the municipal clerk or recorder shall:

(a) make each campaign finance statement filed by a candidate available for public inspection by;

(i) (A) posting an electronic copy or the contents of the statement on the municipality's website no later than seven business days after the statement is filed: and

(B) verifying that the address of the municipality's website has been provided to the lieutenant governor in order to meet the requirements of Subsection 20A-11-103(5); or

(ii) submitting a copy of the statement to the lieutenant governor for posting on the website established by the lieutenant governor under Section 20A-11-103 no later than two business days after the statement is filed.

(6)(a) If a candidate fails to file a campaign finance statement before the municipal general election by the deadline specified in Subsection (2)(a)(i)(A), the municipal clerk or recorder shall inform the appropriate election official who: (i) shall:

(A) if practicable, remove the candidate's name from the ballot by blacking out the candidate's name before the ballots are delivered to voters.

(B) if removing the candidate's name from the ballot is not practicable, inform the voters by any practicable method that the candidate has been disqualified and that votes cast for the candidate will not be counted; and is more not accurate any votes for that candidate.

(ii) may not count any votes for that candidate.
